

## **PAINT CREW SUPERVISOR**

**DISTINGUISHING FEATURES OF THE CLASS:** This is a supervisory position responsible for planning, directing and reviewing the work of several crews engaged in the striping of County highways and the installation of and maintenance of traffic signs. The incumbent is responsible for determining locations for all passing and no passing zones, center and edgeline striping, new traffic signs, all striping and traffic sign maintenance. The work is performed under the general supervision of the Director of Highways. However, the results of the work are considered technically authoritative and are normally accepted without significant change. Direct supervision is exercised over the work of Painters, Motor Equipment Operators and Laborers. Does related work as required.

### **TYPICAL WORK ACTIVITIES:**

Plans and schedules activities of work crews engaged in road striping and sign making operations;  
Prepares daily reports on location of work and the time and materials used;  
Keeps records of new/replaced signs and striping activities;  
Travels over County roads to check for damaged or missing signs;  
Determines dangerous conditions that need added signs or markings;  
Determines locations for all passing zones, no passing zones, school crossings, railroad signs, crosswalks, Stop Bars and turn arrows;  
Supervises installation of the proper signs, barricades and flashing emergency lights for maintenance crews and areas damaged by storms;  
Supervises the maintenance and repair of painting equipment;  
Makes night checks of all County highway signs for sight distance and reflection;  
Drives lead truck during striping activities;  
May participate in snow removal activities;  
May be required to testify as a witness during court proceedings.

### **FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:**

Thorough knowledge of the New York State Manual of Uniform Traffic Control Devices;  
Thorough knowledge of equipment, materials, terminology and safety precautions used in road striping and sign making operations;  
Good knowledge of the County highway system;  
Ability to plan, coordinate and supervise several work crews;  
Ability to maintain records and prepare reports;  
Ability to perform mathematical computations involving fractions, decimals and percentages;

Ability to give clear and concise oral instructions;  
Ability to perform work requiring physical effort;  
Ability to rig and work from scaffolding;  
Ability to perform close, detail work;  
Willingness to respond to emergencies and work overtime;  
Willingness to work outside in adverse weather conditions;  
Dependability;  
Good judgement;  
Physical condition commensurate with the demands of the position.

**MINIMUM QUALIFICATIONS:** Graduation from high school or possession of an equivalency diploma and six years of experience in performing pavement marking or reflective steel sign work.

SPECIAL REQUIREMENT AT TIME OF APPOINTMENT: Possession of the appropriate level Commercial Driver's License (CDL).
