Ongoing issues with stressed healthcare system. There are not enough places to discharge patients. This is causing a backup in the hospitals and spilling over into the EMS sector. There is not an anticipation of additional LTC (Long Term Care) beds. Alternate options are being investigated including Community Paramedicine which has Paramedics performing home visits for individuals who have been discharged from the hospital.

There continues to be a strain on the mental health system. There are multiple funding options but few staff to hire.
