 - a) **Public Safety** Coordinate RMP requirements
 - b) Health, Human and Animal Needs May meeting cancelled
 - a. **COVID**: (Michael Bender) Numbers are very low. NYS has reached 70% and most restrictions have been lifted. The Broome County mass vaccination sites have closed, the NYS mass vaccination site is still open. Numerous smaller (Pop-Up) PODs are occurring through the summer.
 - b. Long term care: (Ron Patti) It has been a long journey. There were some cases recently at Willow Point. Guidelines coming up for testing of vaccinated staff. Vaccinated staff do not need to test twice a week. Personal care giving visits are now allowed. Reports will be coming out soon from CMS with vaccination rates for staff and residents. Locally vaccination rates in LTC facilities is very good. Very close to 70%. There are still staffing shortages. Some facilities have decreased bed availability due to the staff shortage.

Under the ETS, <u>healthcare employers</u> will be required to develop and implement a COVID-19 plan. That plan must include specific steps the employer will take to keep workers at least 6 feet apart indoors, ensure proper use and maintenance of ventilation systems, and provide face masks and COVID-19 related PPE when necessary.

policies and procedures (i.e. health screenings, disease prevention protocols, disinfection practices, etc.), appropriate use and fit of PPE, use of sick leave, and how to safely complete any tasks that may increase risk of COVID-19 transmission.

Hospitals, medical offices, and other healthcare facilities can expect this rule to go into effect as soon as it is published in the *Federal Register*.
