The Committee took the following action with regard to the matters before it:

#37 RESOLUTION CONFIRMING APPOINTMENT TO MEMBERSHIP ON THE BROOME COUNTY LAND BANK BOARD OF DIRECTORS

Mrs. Kaminsky and Mr. Weslar expressed concerns that the appointee doesn't bring any greater regional balance, or any new expertise to the Board.

#60 RESOLUTION AUTHORIZING TRANSFER OF FUNDS FOR THE BROOME COUNTY PUBLIC LIBRARY
