

Pooled Supplemental Needs Trusts

For many the cost of home care is prohibitive and Medicare does not currently cover long-term in-home care needs. Medicaid with a spenddown is an option but often people struggle to pay their expenses when paying a large spend down.

A Pooled Trust is a way for those with income and/or assets above the Medicaid eligibility levels (income levels are \$1,752 for an individual and \$2,371 for a couple) to "eliminate" the Medicaid spenddown that would be required to receive Medicaid. State and Federal legislation allows for those with a disability, as defined by Social Security or Medicaid, to set up an irrevocable supplemental needs trust (SNT). Excess income and/or assets can be placed into a SNT and this makes them eligible for benefits such as Medicaid. Pooled trusts can also be set up for assets that are over the Medicaid limit.

When someone sets up a pooled trust, they can still pay their monthly bills through the trust if there is adequate funding available. No direct payments can be made from the trust to the beneficiary, this would be considered income after the trust is set up, instead the trust can be set up to pay:

- o Rent, or mortgage
- o Property taxes or maintenance costs
- o Utilities, phone, cable, cell phone, etc.
- o Other personal need expenses can be paid

In New York state there are many organizations that provide pooled trusts and they each have minimum deposits, fees and policies. This is a listing of non-profit organizations that provide these trusts in Broome County on the next page.

- Alert Medicaid to the SNT; request Re-budgeting to eliminate Spend-Down
- Follow-up and ensure Medicaid Re-budgeting is done correctly
