BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE April 25, 2024 Weekly Arrest Blotter

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Masai Andrews, age 41 of Endicott, NY and Quinton Archer, age 32 of Binghamton, NY, were charged with Obstructing Government Administration, Class A Misdemeanors, following an investigation into an on-view offense of interfering with an arrest in the City of Binghamton. Andrews was later charged with Criminal Mischief in the 3rd Degree, a Class E Felony, after destroying a chair and door handle while in custody for the above charge.

Kenyon was also charged with Attempted Burglary in the 3rd Degree, a Class D Felony and Criminal Mischief in the 4th Degree, a Class A Misdemeanor, following an investigation into a burglary in the Town of Colesville.
