### **Old Business**

- 1) Committee Updates:
  - Health, Human and Animal Needs Meeting held on 03/21/24
    - Report from Michael Bender- Hospitals are very busy still with the flu and other illnesses. Long-term Care is dealing with the same situation but has been handling it in house. EMS study is complete and the county is working on the next step. Garrick Henry at Lourdes has a new contact due to the change to Guthrie. Reach out for his email and phone number if needed. Department of Social Services is getting out of the code blue season which will help with the sheltering needs in our county.
- 2) Drills and Training Schedule 2024
  - Airshow for 2024: July 6<sup>th</sup> and 7<sup>th</sup> Blue Angels
  - March 14 Medical Response Surge Drill- Participating Agencies: Hospitals, Health Preparedness Coalition, Emergency Managers, EMS, Local Health Departments, Nursing Homes, State OEM.
  - April 8 Total Eclipse- Not Very Eventful locally. I-81 was very busy, but the traffic was flowing.
  - Asset Distribution Exercise Health Dept/Emergency Services- No Date currently.
  - June 13<sup>th</sup> Chemical Surge Tabletop (Department of Health)
  - Trainings:
    - NYS Emergency Management Certification & Training Academy Tier 3- 05/16/2024 in Chemung County.
    - o Intermediate ICS for Expanding Incidents (I-300)- May 21, 23, 28, 30 6:00- 10:00 pm and June  $1^{st}$  8:00 am 4:00 pm.
- 3) Chemical Facility Anti-Terrorism Standards (CFATS) authority was allowed to expire on July 28, 2023. The Program and compliance currently cannot be enforced by CISA (Cybersecurity and Infrastructure Security Agency) Program has still not been renewed. Voluntary Program, ChemLock, can be used in the interim.
- 4) On February 5, 2024, OSHA proposed a new Emergency Response Standard for firefighters, EMS providers, and technical search and rescuers. The <u>proposed</u> <u>Standard</u> would replace the Fire Brigade Standard (29 CFR 1910.156). **OSHA will accept** <u>public comments on the proposed rule until May 6, 2024.</u>

- 4) **RMP Facilities must develop plans** for conducting Emergency Response Exercises by December 19, 2023. This consists of notification exercises, field exercises, and tabletop exercises.

- 5) Risk management Program: Safer Communities by Chemical Accident Prevention: NEW Final Rule effective February 27, 2024
  - Enhancing facility planning and preparedness efforts to strengthen emergency
    response by ensuring chemical release information is timely shared with local
    responders and a community notification system is in place to warn the community
    of any impending release.
  - Emphasizing the requirement for regulated facilities to evaluate risks of natural hazards and climate change, including any associated loss of power.
  - Increased transparency by providing access to RMP facility information for communities nearby.
