State of Emergency

- State of Emergency was formally declared by the County Executive on March 14, 2020 due to COVID-19.
- Currently 7 active Emergency Orders

Emergency Operations Center

- •EOC was formally opened on March 12, 2020
- We are currently at a Level 2 Activation (Partial activation)
- •EOC is working 15 objectives
- •Nearly 1000 "tickets" entered into DisasterLAN
 - 800 requests
 - 800 completed state
- Focus shifting toward recovery and reopening










Operational Highlights

- Education & Feeding
 - More than 750,000 meals distributed
 - 18,000/day
- Donation Drop off
 - Demobilized at Macy's Site
 - 750,000 items received
 - Still accepting donations at Wayne Street
- Community Mask Distribution
 - 104,400 community
 - 38,000 targeted populations
- Mass Fatality Planning
 - Demobilized county portion
 - State portion is expected to demobilize in near future

Contact Tracing

The Health Department continues to expand contact tracing initiative

Within the next week will being to utilize new platform for contact tracing - Comm Care

Broome County still has enough contact tracers internally to meet our need

Testing

- Binghamton University Drive-Through testing site opened. People need to call ahead for an appointment. They are testing symptomatic people and all essential workers regardless of symptoms
- Both UHS and Lourdes using virtual visits and making appointments for patients to be swabbed
- UHS and Lourdes are testing patients and staff for elective surgery
- UHS and Lourdes both working on being able to write orders for patients to receive antibody testing

Nursing Homes

Broome County Health Department working with our local nursing homes to get all residents tested

Governor Cuomo issued Executive Orders to have all nursing home staff tested twice a week. EOC working with nursing homes on procuring sampling materials and finding lab capacity

- •What we learned:
 - The focus needs to remain on protecting the public health. Any recovery which loses sight of this will fail to maintain the public trust and may be more vulnerable to future outbreaks.
 - <u>We should temper expectations for a quick recovery</u>. The economic impacts from this event are deep and widespread. They extend across all sectors and are international in scope. Impacts like this will be long lasting. Any recovery will take an extended period of time.

Meeting the Criteria

METRIC 1

Decline in total net hospitalizations calculated on a 3-day rolling average over a 14-day period

- or -

Few overall cases if net hospitalizations never exceeded 15

METRIC 2

Decline in deaths calculated on a 3day rolling average over a 14-day period

- or -

Few overall cases if 3-day average of daily hospital deaths never

exceeded 5

METRIC 3

Fewer than 2 hospitalizations per 100,000 residents, calculated on 3-day rolling average

METRIC 4

30% of hospital beds available

METRIC 5

30% of ICU beds available
- and Hospitals must have 90day stock of PPE

METRIC 6

30 tests per 1,000 people per month

METRIC 7

30% of ICU beds available - and – Hospitals must have 90day stock of PPE

Phased Reopening

Phase One

- Construction
- Agriculture, Forestry, Fishing and Hunting
- Retail (Limited to curbside or in-store pickup or drop off)
- Manufacturing

Phase Two

- Professional services
- Finance and insurance
- Retail
- Administrative support

- Hotels and accommodations

Phase Four

- Arts, entertainment and recreation
- Education
