In response to a question from the Committee, WPRNC Administrator Adam Aranov stated that the staffing situation at Willow Point is a work in progress, however some positions, including a social worker have been filled. The overall resident census stands at approximately 213 individuals. Mr. Aranov stated that over 100 positions are still vacant. OMB Director Jerome Knebel stated that the small amount of savings from vacant positions at Willow Point are typically transferred to cover temporary staff. Mr. Aranov also stated that he is currently working with the Administration to explore every avenue to invest resources into County Employees at Willow Point. Carried. Ayes-5, Nays-0
