#### COMMITTEE OF THE WHOLE BROOME COUNTY LEGISLATURE MEETING MINUTES JULY 20, 2023

The Committee of the Whole Broome County Legislature met on Thursday, July 20, 2023 in the Legislative Conference Room, Sixth Floor, Edwin L. Crawford County Office Building, Binghamton, New York.

The meeting was called to order by the Chair at 4:07 PM

#### District Attorney School Resource Officer Update

Chief Investigator Jack Collins briefed the Committee on the District Attorney's Office School Resource Officer program. (Presentation attached with the minutes)

In response to a question from the Committee, Mr. Collins explained that some school districts are covered by municipal police departments that are located within the school district.

In response to a question from the Committee, firearms that are utilized by School Resource Officers must be inspected by a firearms instructor.

In response to a question from the Committee, Mr. Collins stated that the continuation of the program, and which agency operates it, is a collaborative decision that should be made with the relevant stakeholders.

In response to a question from the Committee, Mr. Collins stated there has been interest to expand the program to Tioga County, but there are legal requirements and jurisdictional regulations that would need to be overcome in order to accomplish the expansion outside of Broome County.

In response to a question from the Committee, Mr. Collins stated that the challenges that exist related to managing the current program include the large number of participating school districts, each district having several school facilities, and keeping tabs on all personnel and situations occurring simultaneously at schools in real time.

In response to a question from the Committee, Mr. Collins stated that a School Resource Officer would have to be informally approved by the School District and the agency that's managing the SRO Program.

In response to a question from the Committee, Mr. Collins stated that the School Resource Officers are County employees that are structured in a similar way as other District Attorney's Office employees.

#### Veterans Services Facility Update

Broome County Executive Jason Garnar, Acting Public Works Commissioner Roger Brown, DPW Engineer Scott Mastin and representatives from Chianis & Anderson briefed the Committee on the current plans for a Veterans Services Agency Facility slated for 530 State Street in the City of Binghamton. (Presentation attached with the minutes)

In response to a question from the Committee, County Executive Jason Garnar stated that all projects undertaken by Broome County need to be up to code and emergency access will be compliant with regulations. County Executive Garnar also stated that sidewalk clearing and maintenance would be performed by the County.

In response to a question from the Committee, County Executive Jason Garnar stated that there is a need for housing for Veterans and the RFP for this project will include criteria to accommodate Veterans who need housing.

In response to a question from the Committee, County Executive Jason Garnar stated that he expects the housing aspect to be temporary, and case workers will work with Veterans to develop a plan on how long they'd stay at the facility with the goal to transition them to permanent housing or home ownership. County Executive Garnar also stated the scale of housing veterans is determined by the amount of funding dedicated to the project. County Executive Garnar also stated that \$2.8 million dollars out of the \$10 million dollar project total is dedicated to Veteran housing.

Legislator Mary Kaminsky stated that having services for Veterans in one place is advantageous and will greatly assist the Veteran community.

In response to a question from the Committee, County Executive Jason Garnar stated that there was a consideration to allocate fund balance funds for this project, but due to ongoing inconsistencies in funding from New York State, it's advantageous to continue building the County's fund balance to address possible future budget shortfalls impacted by New York State.

In response to a question from the Committee, DPW Engineer Scott Mastin stated that environmental testing was conducted at the site. Some construction debris was identified but no hazardous chemicals were found.

In response to a question from the Committee, County Executive Jason Garnar stated that the office space will be utilized by Veteran service providers and those approvals will be made by the Legislature and Administration.

In response to a question from the Committee, County Executive Jason Garnar stated that Veterans will not pay out of pocket for rent and utilities. Those expenses are covered by the County.

In response to a question from the Committee, County Executive Jason Garnar stated that he's confident the County will be able to collect the amount needed to fund the project through the real property transaction fee. County Executive Garnar also said that fund balance is healthy and there are funds in the Veterans account that can be utilized.

In response to a question from the Committee, representatives from Chianis & Anderson stated that the square footage of the main building is around 14,000 square feet. It was also stated that IT needs will be accommodated at the Veterans facility.

In response to a question from the Committee, County Executive Jason Garnar stated that there was consideration to rent a facility versus building a facility. County Executive Garnar also stated there were not many options that could accommodate the building, the housing and the parking needs for the project.

There being no further business to come before the Committee at this time, a motion to adjourn was made by Mr. Whalen seconded by Mr. Shaw. The meeting adjourned at 5:34 PM.

#### **Mission of the SRO Program**

It is the mission of the Broome County District Attorney Office to facilitate positive relationships with school officials, students, and parents. As such, school resource officers (SROs) shall participate in safety planning, respond to the needs of students, and conduct investigations and other related law enforcement activities on school property in conformance with accepted legal practices and in recognition of the authority and responsibility of school officials to manage the school environment. It is not the policy of this agency to enforce administrative rules on behalf of school officials.

## **Goals & Objectives**

- To foster educational programs and activities that will increase student knowledge of and respect for the law and the function of law enforcement agencies;
- To act swiftly and cooperatively when responding to major disruptions and flagrant criminal offenses at school;
- To report serious crimes that occur on or off campus and to cooperate with law enforcement officials in their investigation. Establish and maintain a close partnership with school administrators in order to provide for a safe school environment;
- Assist school administrators in emergency crisis planning and building security matters. Provide a course of training for school personnel in handling crisis situations and assist in conflict resolution efforts.

## **Goals & Objectives**

- Work to prevent juvenile delinquency through close contact and positive relationships with students;
- Conduct security inspections as permitted by law to deter criminal or delinquent activities;
- Monitor crime statistics and work with local patrol officers and students together to design crime prevention strategies.

- SRO's do not change from district to district.



#### Local Veteran Issues of Concern

- On average Broome County has an estimated 20 homeless veterans at any given time

 Create a welcoming one stop shop for Veteran services in Broome County.








<u>Street View</u> 530 State Street, Binghamton


- Purchased from Salvation Army

- Strongly supported local veteran community






A One Stop Shop for Veterans Services



- Ten units of tiny homes, first to be built in Broome County

Ten Units of Tiny Homes for Veterans

- ADA accessible
- 6 single and 4 double apartments
- Include all appliances
- Managed and operated by a local housing management company (RFP forthcoming)







# Timeline

- August 2023: \$10 million bonding resolution
- August 2023: home rule request sent to state
- Fall 2023: bids out/construction starts
- Fall 2023: rfp selection for housing management
- Fall/Winter 2024: construction and move to center complete

## Funding Sources

- Federal Earmark (Molinaro/Schumer/Gillibrand): \$1,000,000
- NY Senate SAM Grant (Akshar): \$1,000,000
- NY Assembly SAM Grant (Lupardo): \$500,000
- NY ESD Grant: \$650,000
- TOTAL: \$3,150,000

#### Increase Real Estate Transfer Fee to Fund Project

- Broome Currently Collects \$700,000 per year
- Proposal would be to increase fee \$1 to pay for the project
- Fee would increase from \$5 per \$1,000 to \$6 per \$1,000
- Home rule request sent this year, approval by State next year
- Average mortgage of \$150,000 would see fee increase of \$150 (\$750 to \$900)
- Fee has not been changed in decades
- No net support from general fund
