Comments from the County Executive, Jeffrey P. Kraham:

Mr. Kraham presented the members of the Legislature with an **'IMPACT PAPER'** relating to 'ELIMINATION OF THE BROOME COUNTY SHARE OF THE SALES TAX ON CLOTHING.' (See related legislation, Resolution # 97-137). Mr. Kraham noted that in 1996, Broome County experienced a 5.5% growth in sales tax revenue. The collections of \$47,715,116 exceeded the budgeted amount by \$765,116.

- Mr. Kraham's presentation paper included the following statements:
- <u>In 1997</u>, after the sales tax on clothing and related items is eliminated, and assuming the level of sales tax revenue growth is maintained at the 1996 rate of 5.5%, we will realize a <u>SURPLUS OF \$1,501,765</u> over the 1997 budgeted amount of \$46,950,000.
- <u>In 1998</u>, assuming that same 5.5% growth rate in annual sales tax revenue, the <u>SURPLUS WILL BE \$1,378,505</u>.
- <u>In</u> <u>1997</u>, THESE COUNTY SALES TAX FIGURES TRANSLATE TO A <u>minimum taxpayer savings of</u> \$2,715,651.
- In 1998, with a full 12 months of county sales tax amnesty, the **TAXPAYER SAVINGS WILL GROW TO \$6,821,457.**
- Mr. Kraham's remarks were based on several assumptions, mentioned in

the 'Impact Paper':

- 1. An implementation date of 8/1/97 for the sales tax exemption on clothing.
- 2. A constant rate of growth of the sales tax of 5.5%.

The County Executive's paper indicated, that, "These figures do not take into consideration my belief that, as a result of the elimination of sales tax savings on clothing, sales tax revenue in other sectors of our economy will increase dramatically. This will be due to increased consumer confidence, additional disposable income and an influx of non-Broome County shoppers."
